ARTICLES OF INCORPORATION

FOR

ARTICLE I

The name of this corporation is MYSTIC LAKES RANCH, INC.

ARTICLE II

This corporation is organized for the purpose of engaging in and transacting any lawfull business permitted under the laws of the United States and the State of Florida. The principle business activity of this corporation is Equestrian Services.
