

**ARTICLE I - NAME**

The name of this corporation is ALLIED CAPITAL, INC.  
and the principal office address is: 7355 SW 96 Street, Miami, FL 33156.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence unless sooner dissolved according to the law.

**ARTICLE III - PURPOSE**

This corporation is organized to engage in the business of investing in stocks, business ventures, options, and other profitable investment opportunities, in conformity with the the existing laws, municipal rules and regulations or such as may be hereafter enacted; and to engage in any other lawful business from time to time.

#### **ARTICLE X - AMENDMENT**



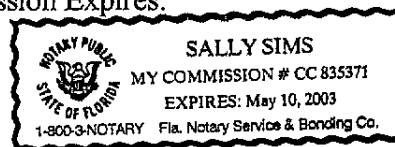
