Name

The name of the corporation is CALL CENTER JOBS, INC.

ARTICLE II

Duration

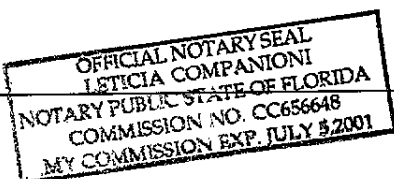


