ARTICLE 1 - NAME/ADDRESS

The name of this corporation is ANNA MARIA CREAMERY, INC., and its mailing and principal office address is 6425 28th Avenue East, Bradenton, FL 34208.

ARTICLE 2 - PURPOSE


