Name

The name of the Corporation is **Trejo & Sons, Inc.**, hereinafter referred to as the "Corporation."

II.
Purposes

The purpose of the Corporation is as Harvest Contracting, including but not limited to providing personnel, equipment and other services to local agricultural businesses.

III.
Principal Office and Registered Agent

When Articles of Incorporation Effective


