ARTICLES OF INCORPORATION OF

WARING BROTHERS OUTDOOR, INC.



The undersigned subscribes to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is Waring Brothers Outdoor, Inc., whose principal office address is 1416 S. Lake Pleasant Rd., Apopka, FL 32703.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
