ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE REGENT FLORIDA REAL ESTATE HOLDINGS, INC.

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I Name

The name of this corporation shall be:

ARTICLE II Principal Office and Mailing Address

ARTICLE III **Business and Purposes**

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

ARTICLE IV Capital Stock

The aggregate number of shares of capital stock authorized to be issued by (a) this corporation is 100 shares of common stock with a no par value per share.
