ARTICLE I  
CORPORATE NAME

The name of the corporation is DISCOVERY OF WEST BOCA, INC.

ARTICLE II  
DURATION

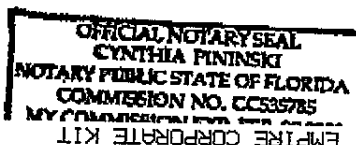
