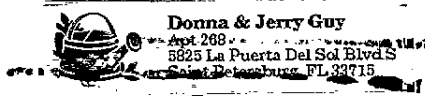

First: Amendments Adopted:

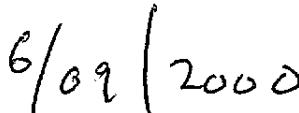
