# ARTICLES OF INCORPORATION of FREE FAMILY FUN, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, for the purpose of forming a corporation under The Florida General Corporation Act, Florida Statutes Chapter 607, hereby adopt the following Articles of Incorporation

## ARTICLE I - NAME

This corporation shall be known as FREE FAMILY FUN, INC.
