ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ARBEAR, INC.

Pursuant to Section 607.1003 of the Florida Statutes, the Articles of Incorporation of ARBEAR, INC. as filed with the Florida Department of State, effective January 18, 2000, are hereby amended as follows:

1. Article IV of the Articles of Incorporation shall be replaced as follows:

"ARTICLE IV - CAPITAL STOCK

There shall be two (2) classes of capital stock. The Corporation is authorized to issue a maximum of 100,000 shares of Class A Voting Common Stock with no par value per share and 9,900,000 shares of Class B Non-Voting Common Stock with no par value per share. Each share of existing stock shall be converted into one (1) share of Class A Voting Stock and ninety-nine (99) shares of Class B Non-Voting Stock. Other than the Class A Voting Stock having the right to vote and the Class B Non-Voting Stock not having such right, each share of Class A or Class B stock shall be treated equally in all respects."
