The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The NAME of the Corporation is **JBSB, Inc.**

ARTICLE TWO

The DURATION of the Corporation is **PERPETUAL**.

ARTICLE THREE

The GENERAL PURPOSE for which the Corporation is organized is to provide Internet Services to business and retail establishments by enabling Internet commerce.

ARTICLE FOUR

The aggregate NUMBER OF SHARES which the Corporation is authorized to issue is ONE THOUSAND SHARES (1000). Such shares shall be of a single class and shall have a par value of ONE DOLLAR (\$1.00) per share.


