

ARTICLES OF INCORPORATION



OF

NAPLES PSYCHIATRIC AND COUNSELING SERVICES, INC.

The undersigned, acting as the Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is: NAPLES PSYCHIATRIC AND COUNSELING SERVICES, INC.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purposes for which the corporation is organized are to provide psychiatric and counseling support services, as well as to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV

Authorized shares

Number: The aggregate number of shares that the corporation

shall have the authority to issue is 2000 shares of

Class A Common Stock.

Voting Rights: Of the 2000 Class A Common Shares authorized,

1000 of these shares will entitle the holder to 1 vote per share; the remaining 1000 shares will be non-

voting.

Par Value: Each share shall have a stated par value of \$1.00.

ARTICLE V

Notice must be given by any shareholder to the President or Vice-President of said corporation not less than 24 hours prior to the time set for the holding of the shareholder's meeting for the election of directors that said shareholder intends to cumulate his vote at said election.
