

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of the corporation is RIBAR SERVICES INTERNATIONAL INC.

**ARTICLE II**

**NATURE OF BUSINESS**

The corporation is organized for the business of consulting, management services, product sales and related items, but may engage in any activity or business permitted under the laws of the United States or America and of the State of Florida.

**CAPITAL STOCK**
