

#### ARTICLE I. NAME

The name of the corporation is Newell Pumping Company, Inc.

## ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.

#### ARTICLE III. PURPOSE

The corporation is organized for the purpose of transacting concrete pumping and any and all lawful business.

## ARTICLE IV. CAPITAL STOCK
