**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural persons, hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is WALKER & TRAVIS INVESTMENTS, INC..

**ARTICLE II**

The existence of the Corporation shall begin on January 18, 2000.

**ARTICLE III**

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.
