The undersigned incorporator hereby forms and organizes a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is ULTIMATE MAINTENANCE, INC.

ARTICLE II - PRINCIPAL OFFICE
