## ARTICLES OF INCORPORATION OF COMPLETED CIRCUITS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I: Corporate Name. The name of the corporation is COMPLETED CIRCUITS, INC.

ARTICLE II: <u>Corporate Existence.</u> The corporation shall exist in perpetuity commencing as of the execution of these Articles.

ARTICLE III: Corporate Purpose. The corporation is organized for the purpose of providing engineering services, including schematics and design work, circuit board assembly, printed circuit boards, design assembly, and for any and all lawful business allowed under the State of Florida or the United States of America.

ARTICLE IV: <u>Authorized Stock.</u> The corporation is authorized to issue 10,000 shares of common stock, par value \$1.00 each.
