ARTICLE I:

The name of the Corporation is 624 Collins Avenue, Inc.,

a Florida corporation.

ARTICLE II:

The Articles of Incorporation for the Corporation are

hereby amended as follows:

1. The sole purpose of the Corporation shall be to serve as general partner of 624 Collins Avenue, Ltd., a Florida limited partnership (the "Partnership").
