SECOND: The date of each amendment's adoption is January 31, 2000.

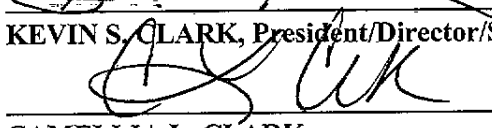
THIRD: The amendment was approved by all of the shareholders, directors, and incorporators of the corporation.
