

**ARTICLES OF INCORPORATION**

**ARTICLE I**

The name of the corporation is D&H 18 INVESTMENTS, INC. (hereafter the "Corporation")

**ARTICLE II**

The address of the principal office and the mailing address of the Corporation is 1656 COLLINS AVENUE, MIAMI BEACH, FLORIDA 33139.

**ARTICLE III**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

**Number of Shares Authorized:** 1,000  
**Par Value Per Share:** \$0.00  
**Class of Stock:** Common

**ARTICLE IV**

The Corporation shall hold a special meeting of shareholders only:

The number of directors constituting the initial Board of Directors is one (1), and the names and addresses of the members of the initial Board of Directors, who are to serve as the Corporation's directors until their successors are duly elected and qualified are:

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by any law in existence either now or hereafter.


