ARTICLES OF INCORPORATION**OF****ANA MARIA CAMAROTTI, D.M.D., P.A.**

The undersigned natural person, legally authorized to practice Dentistry in the State of Florida, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I.

The name of the corporation is **ANA MARIA CAMAROTTI, D.M.D., P.A.**

ARTICLE II.

The period of the corporation's duration shall perpetual or until dissolved on a vote of the shareholders as hereafter provided.

ARTICLE III.

The purpose of the corporation is to practice the profession of Dentistry. The sole and exclusive professional services to be rendered by the corporation is dental services.

ARTICLE IV.

The total number of shares of capital stock which the corporation shall be authorized to issue is ONE THOUSAND (1,000) shares. Such shares shall be of a single class of common stock, and shall have a par value of \$1.00.

dentistry is not less than FIVE HUNDRED DOLLARS (\$500.00).

ARTICLE VI.

The address of the corporation's principal office is 714 South Street, Key West, Florida 33040. The name of the initial registered agent of the corporation, located at such office, is ANA MARIA CAMAROTTI.

ARTICLE VII.

This corporation shall have all the rights and powers now or hereafter conferred on professional corporations by the laws of the State of Florida.

ARTICLE VIII.

The corporation is to be managed by a board of directors. The corporation shall have one director initially. The number of directors may be increased from time to time by the by-laws but shall never be less than one. The name and address of the initial director of this corporation is: ANA MARIA CAMAROTTI, 714 South Street, Key West, FL 33040.

The initial director shall hold office until her successor is elected and qualifies as provided in the bylaws. Thereafter, the term of office of each director shall be one year and until the election and qualification of a successor. The number of directors set forth herein and constituting the initial board of directors shall be the authorized number of directors until such number is changed by a bylaw duly adopted by the shareholders.

ARTICLE X.

The initial director shall submit the proposed bylaws to the shareholders at a meeting to be held for that purpose. Following the adoption of bylaws by a majority of the shareholders, the internal affairs of the corporation are to be regulated and managed in accordance with such bylaws.

ARTICLE XI.

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least two-thirds of the outstanding shares of the corporation entitled to vote thereon. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by her.
