ARTICLES OF INCORPORATION

OF

"SUHAD FOOD MART, INC."

We, the undersigned subscribers to these Articles Of Incorporation, a natural person competent to contract, do hereby form a corporation under the Laws of the State of Florida.

ARTICLE 1.

The name of the corporation is,

"SUHAD FOOD MART, INC."

ARTICLE II.

This corporation may engage in any activity or business permitted under the laws, of the United States and of this State.

ARTICLE III.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is ONE THOUSAND shares of common stock, each share having a par value of FIVE DOLLAR (\$5.00). Said stock shall be divided in the following manner; MOHAMMED M. ABU-SBEITAN SEVENTY FIVE PER CENT (75%) AND GHASSAN ALHINDI TWENTY FIVE PER CENT

ARTICLE IV.

The amount of the capital with which this corporation shall begin business is FIVE THOUSAND DOLLARS (\$5000.00).

ARTICLE V.

The initial post office address of the registered office of this corporation is to be 721 N. Lyons Road #15105 Coconut Creek, Florida 33063-6724, the Board of Directors may change the address from time to time designate such other post office address and place for the registered office as it may see fit. The name of the initial registered agent shall be Mohammed M. Abu-Sbeitan. The principal address and the registered office shall be the same.

ARTICLE VI.

The corporation shall perpetual existence.

ARTICLE VII.

The number of Directors of this corporation shall be provided in the By-Laws, but shall not be less than TWO (2) in number nor more than SEVEN (7) in number and shall be one (2) in number until otherwise fixed or changed by the By-Laws.

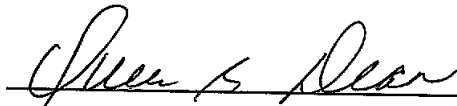

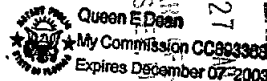

These Articles Of Incorporation shall be effective upon filing with, and acceptance thereof, by the Secretary of the State of Florida.

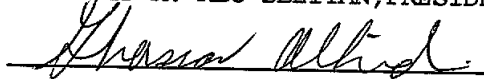
ARTICLE XII
