ARTICLE I - NAME

The name of this Corporation is CAN IT, INC.

ARTICLE II - DURATION

This corporation shall exist into perpetuity unless sooner dissolved by law.

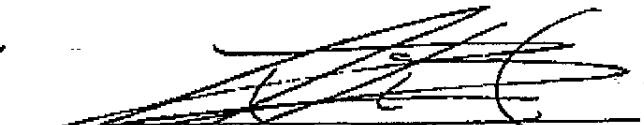
