ARTICLES OF INCORPORATION OF

The aggregate number of shares which the corporation shall have authority to issue is 100, at no par value.

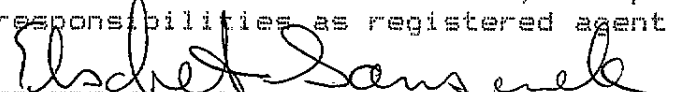
Article Five

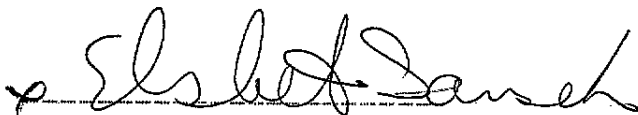
