#### ARTICLES OF INCORPORATION

The undersigned subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### **ARTICLE I. NAME**

The name of this corporation is:

# ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted is:

- To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages,

- To purchase the corporate assets of any other corporation and engage in the same or other character of business.
