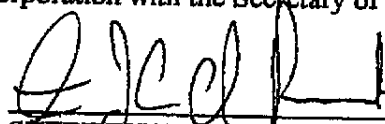

ARTICLE VIII

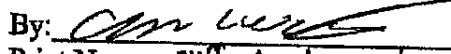
