ARTICLES OF INCORPORATION
OF
SUNSHINE TERMINAL 11 CORP.

ARTICLE I - NAME

The name of this corporation is Sunshine Terminal 11 Corp.

ARTICLE II - CORPORATE EXISTENCE

The existence of this corporation shall commence on the 26th day of January, 2000; provided that if such day be unauthorized under law, then on the earliest day allowable pursuant to Florida law for the commencement of corporate existence. The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

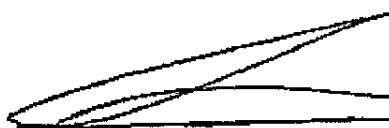
