

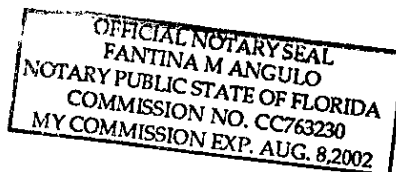
1. Harry Rubi is the President of SILENCE OF THE HAMMER, INC., a Florida corporation, (hereinafter "Corporation").


