To Whom It May Concern:

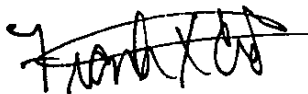
I am the owner and president of Plant Management, Corp. I formed my corporation in January of 2000. In the summer of 2002 I moved my corporate offices to a new address. I failed to inform the Division of Corporations of my new address.

Due to my move, I did not receive any copies of or any notices of my Annual Reports. Since I did not receive any of these items I did not file with the Division of Corporations for my corporation for the years 2002 through 2006. I recently visited my attorney to ask a question about my corporation. He looked up the state records and informed me that my corporation had been "Administratively Dissolved". I did not know what that meant. He then informed me that I was required to file annual reports with the Division of Corporations to keep my corporation in good standing.

I did not know this and as I did not receive any papers from the Division of Corporations due to my moving, I never filed. My attorney has prepared the enclosed Application for Reinstatement.
