ARTICLES OF INCORPORATION

We, the undersigned, as proper persons acting as incorporators of a corporation
under the laws of the State of Florida, adopt the following articles of incorporation:

- FIRST** The name of the corporation is Health Line Education, Incorporated
- SECOND** The period of its duration is perpetual.
- THIRD** The purpose of the corporation is to provide education classes to nursing assistant students in preparation for their state exam and continuing education to medical professionals. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purpose which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.
- FOURTH** The aggregate number of authorized shares is one hundred (100).
- FIFTH** The corporation will not commence business until at least five hundred (500) dollars has been received by it as consideration for the issuance of shares.
- SIXTH** Cumulative voting of shares of stock is authorized.
- SEVENTH** Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are listed in the corporate bylaws.
- EIGHTH** Provisions for regulating of the internal affairs of the corporation are listed in the corporate bylaws.
