ARTICLE I - NAME

The name of this corporation is J & L FABRICATORS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - COMMENCEMENT OF CORPORATE BUSINESS

This corporation requests the date of corporate existence of February 1, 2000.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
