ARTICLES OF INCORPORATION
OF
LOGICAL ENTERPRISES, INC.

The undersigned, incorporator(s) for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following articles of incorporation:

ARTICLE ONE

The name of this corporation is LOGICAL ENTERPRISES, INC.

ARTICLE TWO

The corporation is to have perpetual existence.

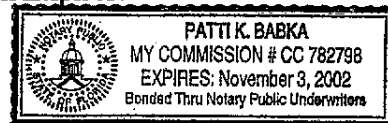
