OF

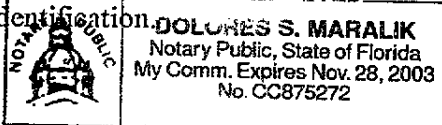


