ARTICLES OF INCORPORATION OF WORLD YACHT CLUB, INC.

The undersigned, acting as Incorporators of a Corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I NAME
