The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### **ARTICLE V PURPOSE**

- f. to make contracts and guarantees and incur liabilities, borrow money at such rate or interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all it's property franchises, and income.
  - g. To lend money for its corporate purchases, invest and reinvest funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
