ARTICLES OF INCORPORATION OF DUNN & WEST, INC.

THE UNDERSIGNED, acting as sole incorporator of DUNN & WEST, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be **DUNN & WEST, INC.**
