### ARTICLES OF INCORPORATION

I, the undersigned subscriber to these Articles of Incorporation; natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

## ARTICLE I - NAME

The name of this corporation shall be: BOB'S ICE CREAM, INC.

# ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be: 758 S. THIRD ST., JACKSONVILLE BEACH, FL 32250

# ARTICLE III - DURATION
