ARTICLE 3. The principal place of business and mailing address of this corporation shall be 2958 Marqueses Court, Windermere, Florida 34786.


ARTICLE 4. The corporation is authorized to have outstanding at any one time 100 shares of stock, at a par value of \$1.00 per share.
