ARTICLE 3. The principal place of business and mailing address of this corporation shall be 6807 South Orange Avenue, Orlando, Florida 32809


ARTICLE 4. The corporation is authorized to have outstanding at any one time 100 shares of stock, at a par value of \$1.00 per share.


