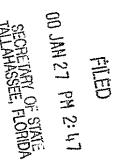

ARTICLES OF INCORPORATION OF JAMES BUSHOUSE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereas adopts the following Articles of Incorporation:

Article I: The name of the Corporation is James Bushouse, Inc.

Article II: Corporation's principal office is located at 1176 S. W. 4th Court, Boca Raton, Florida 33432.

Article III: The purpose or purposes for which the Corporation is organized are to engage in any activity of business permitted under the laws of the United States and of the State of Florida.

Article IV: The aggregate number of Shares that the Corporation shall have the authority to issue is 200 Shares of Capital Stock with a par value of \$0.25 per Share:
