Articles of Incorporation OF

DAVID LASANEN DISTRIBUTING, Inc.

The undersigned subscriber to these Articles of Incorporation, hereby forms a corporation under the Florida General Corporation Act.

ARTICLE I

The name of the corporation is: DAVID LASANEN DISTRIBUTING, Inc.

ARTICLE II

The duration of the corporation is perpetual and the purpose is to provide general sales and marketing of personal care products.

ARTICLE III

The principal office and mailing address is: 6706 Oak Hill, North Lauderdale, Florida 33068.

ARTICLE IV

The corporation is authorized to have outstanding one class of stock, designated as Common Stock. The maximum numbers of shares of stock is 100 of a parvalue of \$1.00 per share. Holders of Common Stock are entitled to one vote per share with no

cumulative voting. Holders of Common Stock shall have preemptive rights to subscribe to the corporation's securities and are entitled to receive the net assets of the corporation upon dissolution.

ARTICLE V

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.
