WE, THE UNDERSIGNED, Hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

ARTICLE I, NAME

ARTICLE X, AMENDMENT

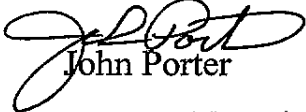
