**ARTICLE 1. Name**

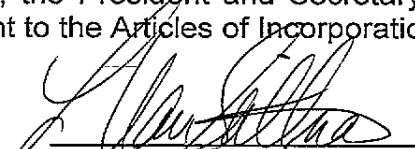
