The principal place of business and mailing address of this corporation are 2560 NW 7 Street, Miami, Fl. 33125.

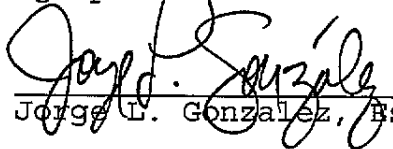
ARTICLE III. CAPITAL STOCK

ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE

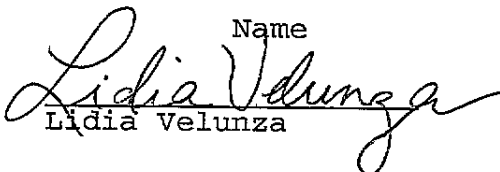
