ARTICLE I

The name of the corporation is Sunshine Liquidators.Com, Inc. The principle office and mailing address is:

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE VIII





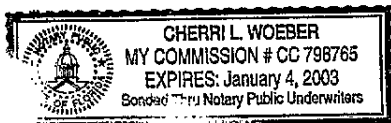
