**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of DWDH, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I

COMMENCEMENT OF CORPORATE EXISTENCE


