# ARTICLES OF INCORPORATION

# OF

The undersigned does hereby make, subscribe, acknowledge and files these Articles of Incorporation, for the purpose of forming a corporation under the laws of the State of Florida.

# ARTICLE 1 - NAME

The name of this corporation shall be:

Perfect Paint & Pressure Works, Inc. 1595 Winston Lane Orange Park, FL 32073

# ARTICLE 2 - PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may hereafter be amended.

# ARTICLE 3- CAPITAL STOCK

- 3.1 This Corporation is authorized to issue 500 shares of one dollar par value stock which shall be designated as "Common Stock".

- The board of directors of the Corporation may, by articles supplementary, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of stock.

# ARTICLE 4: TERM OF EXISTENCE

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
