ARTICLES OF INCORPORATION OF BELA'S CORNER, INC.

Company of the second s The undersigned incorporator, for the purpose of forming corporation under the Florida Business Corporation Act, hereb adopts the following Articles of Incorporation.

ARTICLE I

NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION

The name of the Corporation is BELA'S CORNER, INC. The principal place of business of the Corporation is 3385 S. US HWY 17-92 SUITE #101, CASSELBEERY, FL 32707. The duration of the Corporation is perpetual.

ARTICLE II

REGISTERED OFFICE AND AGENT

The address of the registered office in the state of Florida is 3385 S. US HWY 17-92 SUITE #101 in the city of CASSELBERRY in the County of SEMINOLE. The name of the registered agent at such address is PRATUL PATEL.

ARTICLE III

CORPORATE PURPOSE, POWERS AND RIGHTS

- The nature of the business to be conducted or promoted and the purpose of the Corporation are to engage in any lawful act or activity for which Corporation may be organized under the Business Corporation Act of Florida.

The Board of Directors may distribute in kind to the holders of Common Stock such remaining assets of the Corporation or may sell transfer or otherwise dispose of all or any part of such remaining assets to any other Corporation, trust or other entity and receive payment therefor in cash, stock or obligations of such other Corporation, trust or other entity, or any combination thereof, and may sell all or any part of the consideration so received and distribute any balance thereof in kind to holders of Common Stock.
