DURATION:

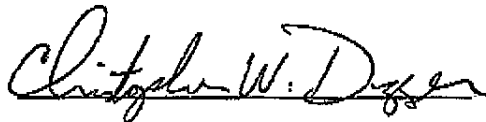

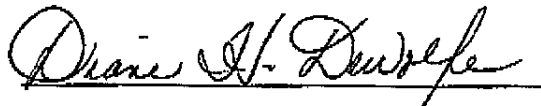
